

**MEDIA CONSENT AND RELEASE**

The Diocese of Metuchen may edit, modify, add to, and/or delete any elements or components of the Image and such Materials may be used in conjunction with or without the use of my name, image, or likeness at the Diocese of Metuchen's sole discretion.

I hereby agree that I will not assert or maintain against the Diocese of Metuchen any claim, action, suit or demand of any kind or nature, whatsoever including, but not limited to, those grounded upon invasion of the right of privacy, defamation, emotional distress, libel, slander, or any other reason in connection with the exercise of consent or the rights granted pursuant to this release. I further waive, assign and release to the Diocese of Metuchen any moral rights and release the Diocese of Metuchen from any liability for what I might deem misrepresentation of my name, image, or likeness by virtue of alterations, optical illusions, or faulty mechanical reproduction.

This release is made on behalf of myself, my heirs, executors, administrators and assigns and is to be governed by the internal substantive laws of the State of New Jersey for agreements to be wholly performed therein without regard to any choice of law principles. I have full legal capacity to grant this consent and release, and have read and understood the above consent and release prior to its execution. I have granted the foregoing consent and authority voluntarily and with the knowledge and understanding that the Diocese of Metuchen will incur substantial expense in reliance thereon.
